- Cleaning and CCTV Investigation of 6" – 8" sanitary sewer – 33,465 L.F.
- Cleaning and CCTV Investigation of 10" – 12" sanitary sewer – 117,564 L.F.
- Cleaning and CCTV Investigation of 15" – 21" sanitary sewer – 47,599 L.F.
- Cleaning and CCTV Investigation of 24" – 30" sanitary sewer – 21,657 L.F.
- Cleaning and CCTV Investigation of 36" sanitary sewer – 5,837 L.F.
- Locate, adjust/rebuild existing sanitary sewer structures – 150 EA.

All CCTV (Closed Circuit Televising) inspections shall be performed as a NASSCO Pipeline Assessment and Certification Program (PACP) certified operator. All inspection reports shall be produced using (CCTV) inspection software provided by a (PACP) certified vendor. For matting and layout, i.e. observation and defect codes, they shall be NASSCO PACP standard.

The right is reserved by the Charter Township of Shelby to accept any proposal, to reject any proposal, and to waive irregularities in proposals. The successful bidder will be required to furnish satisfactory performance, maintenance and guarantee, labor and material bonds and insurance certificates.

The Charter Township of Shelby prefers that interested bidders have a business located in the State of Michigan, in Macomb, Oakland or Wayne County.

No bid may be withdrawn after the above date and time for receiving bids for a period of one hundred twenty (120) days.
