AGREEMENT

THIS AGREEMENT is made between Kodiak Emergency Vehicles, 10120 W. Grand River Highway, Grand Ledge, MI 48837 ("COMPANY") and the Shelby Township, 52700 Van Dyke Ave., Shelby Township, MI 48316 ("Buyer"). THE COMPANY agrees to sell and the BUYER agrees to purchase One (1) Braun Chief XL F-450 4X4 ambulances as described in the COMPANY'S Proposal, all in accordance with the terms and conditions of the Agreement. The finished rescue ambulances shall be delivered from the factory and delivered by COMPANY personnel to the Shelby Township Fire Department.

BUYER AGREES to pay a CONTRACT PRICE \$222,771.00 for one (1) Braun Chief XL F-450 Ambulance per proposed work order and specification.
